NOTICE

Birbhum.—No. 10368 L.A.(P.W.).—3rd June 1957.—Whereas 15.27 acres, more or less, of land situate in or near the villages of Muchiara and 10 others described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for irrigation and drainage, namely, for construction of Minor No. 1 of Distributary No. 2, of Bakreswar Kopai Branch Canal from chainage 0 to chainage 144.0, in connection with Mayurakshi Reservoir Project;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given, under the provision of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.
