#### NOTICE

BIRBHUM— No. 145 L. A. (II) / Spl / I & W— 24th June, 1992— whereas 2.33 acres or .9429 hectare, more or less, of land situated in or near the villages of Changuria and two others described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (1A) for the purpose of providing facilities for the construction of a water-course off taking from ch. 60.00 of distributory No 2 of M. B. Main canal in connection with M. R. P.

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948, West Bengal Act II of 1948, to all whom it may concern.
