the Governor that land is likely to be needed to be
taken by Government at the public expense for a public
purpose, viz, for construction of Ash utilisation Project
of B.K.T P.P. in the mouza Bongaon, Jurisdiction
List No. 131, P. S. Sadaipur, District Birbhum, it is
hereby notified that for the above purpose a piece of
land comprising L. R. Plets as detailed below and
measuring, more or less, 4.48 hectares (11.07 acres),
bounded as specified below is likely to be needed
within the aforesaid mouza Bongaon.

This notification is made, under the provisions of section 4 of Act I of 1894, to all whom it may concern.
