#### NOTICE

BIRBHUM—No. 15/P.W. (R)-D/ESP—dated 23rd October, 1992— Whereas 01.110 acres or 0.4494 hectares, more or less, of land situated in or near the villages of Alinagar & Sonhsal described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (1A) for the purpose of maintaining supplies and services essential to the life of the community for providing facilities for transport/communication, namely, for the purpose of construction and widening of A. D. B. Project of Panagarh-Dubrjpur-Moregram-Road.

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948, West Bengal Act II of 1948, to all whom it may concern.

A plan of the land may be inspected in the office of the Collector, Birbhum (Special Land Acquisition Department), Suri.
