DECLARATION.

No. 18047 L.A.—*The 19th December 1927.*—Whereas it appears to the Governor in Council that land is required to be taken by Government at the expense of the Santiniketan International University for a public purpose, viz., for agricultural and other educational purposes, in the villages of (1) Ballabhpur (pargana Alinagar), (2) Krishnanagar or Surul (pargana Barbeksingh), (3) Arazi Shyambati, (4) Madhusudanpur (pargana Barbeksingh), (5) Taltori and (6) Bolpur (pargana Sheopur), zilla Birbhum, it is hereby declared that for the above purposes four pieces of land altogether measuring, more or less, 728·59 acres and bounded as described below :—

Block A.

In villages Ballabhpur (pargana Alinagar) and Krishnanagar or Surul (pargana Barbeksingh). Area 583·21 acres.

North and East—By District Board road to Surul,
