**Birbhum.**—No. 215421.A.(P.W.).—18th November 1957.—Whereas 7.69 acres, more or less, of land situated in or near the villages of Sakadda and 7 others described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for irrigation and drainage, namely, for excavation of Distributary No. 4 Ex. Kopai South Main Canal in connection with Mayurakshi Reservoir Project:

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act the Governor acquires such land being required for a public purpose as aforesaid.
