**BIRBHUM.**—No 4681-L.A.(P.W.).—20th July 1984.—Whereas the Governor is satisfied that land is needed for a public purpose, namely, for reservoir area of Hinglow Dam in mauzas Hanulia and Sagarbhanga, jurisdiction list Nos. 66 and 63 respectively, police-station Khoyrasol, district Birbhum, it is hereby declared that pieces of land comprising cadastral survey plots as described below and altogether measuring, more or less, 1.1130 hectares (2.75 acres) are needed for the aforesaid public purpose at the public expenses within the aforesaid mauzas of Hanulia and Sagarbhanga.

This declaration is made under the provisions of section 6 of Act I of 1894 to all whom it may concern.

A plan of the land may be inspected in the office of the Special Land Acquisition Officer, Birbhum.
