### NOTICE

BIRBHUM—No. 17 L.A. (II)/Spl./PW (Roads)—23rd June, 1992—Whereas 5.6903 hectares (14.05 acres), more or less, of land situated in or near the village of Dakshin Maligram and another described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (1A) for the purpose of providing facilities for transport/communication, namely for construction of Sibagram - Satpalsa actually Sibagram to Noapara Road (section from 10th M. P. to end point 11 M. P. 2900 ft.)

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.
