Whereas the Governor is satisfied that land is needed for a public purpose not being a purpose of the Union, namely for construction of Reservoir of Bk. T.P.P. in the Mouza Matijapur, Jurisdiction List No. 63, P.S. Dubrajpur, District Birbhum, it is hereby declared that a piece of land comprising R.S. Settlement plots as detailed below and measuring more or less 20.1945 Hectares (49.90 Acres) bounded as specified below is needed for the abovesaid public purpose at the public expense within the aforesaid Mouza Matijapur.

Whereas it appears to the Governor that land is likely to be needed to be taken by Government at the public expense for a public purpose, Viz., for construction of reservoir of Bakreswar T.P. project in the mouza Matijapur, Jurisdiction list No. 63, P.S. Dubrajpur, District Birbhum, it is hereby notified that for the above purpose a piece of land comprising revisional settlement plots as detailed below and measuring, more or less 20.1945 hectares (49.90 acres), bounded as specified below is likely to be needed within the aforesaid mouza Matijapur.

This notification is made, under the provision of section 4 of Act I of 1894 to all whom it may concern.

A Plan of the land may be inspected in the Office of the Spl. Land Acquisition Collector, Birbhum at Suri.

In exercise of the powers conferred by the aforesaid section, the Governor is pleased to authorize the officers for the time being engaged in the undertaking, with their servants and workmen, to enter upon and survey the land and do all other acts required or permitted by that section.

In exercise of the powers conferred by sub-section (4) of section 17 of the Land Acquisition Act, 1894 (Act I of 1894), the Governor is pleased to direct that the provisions of section 5A of the Act shall not apply to the lands as described in the Schedule below to which in the opinion of the Governor, the provisions of sub-section (1) of section 17 of the said Act are applicable.
