BIRBHUM:— NO. 3536-L.A. (II)/1I-306/68-25th February 1969. — whereas 0.8238 of a hectare (1.79 acres) more or less, of land situate in or near the village of Kages and two others described below has been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition And Acquisition) Act, 1948, by the person authorised under the said section 3(1A) of the Act for the public of providing facilities for irrigation, namely, for construction of a Water Course for chainage 535.00 of Mayurakshi Dwarka Branch Canal in connection with Mayurakshi Reservoir Project;

Now, therefore, notice is hereby given that in pursuance of section 14(a) of the said Act, the Governor acquires such land being required for the public purpose as aforesaid.

This notice is given under the provision of Sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.
