**BIRBHUM NO. -1064/WS/LA/5/10-11(iv)/III/LA dated 26<sup>th</sup> July, 2010-** Whereas it appears to the Governor that land is likely to be needed to be taken by Government at the public expense for a public purpose, viz , for Construction of Narayanpur Water Supply Scheme Rampurhat- I Block- in Mouza-Balia Mritunjoypur, J.L.-4, P.S.- Rampurhat, District-Birbhum, it is hereby notified that for the above purpose a piece of land comprising L. R. Settlement Plot as detailed below and measuring more or less 0.0546 hectare (0.135 acre) bounded as specified below is likely to be needed within the aforesaid Mouza- Balia Mritunjoypur.

This notification is made, under the provision of section 4 of Act I of 1894 to all whom it may concern.

A plan of the land may be inspected in the office of the Special Land Acquisition Officer, Birbhum, Suri.

In exercise of the powers conferred by the aforesaid section, the Governor is pleased to authorize the officers for the time being engaged in the undertaking, with their servants and workmen to enter upon and survey the land and do all other acts required or permitted by that section.

Any person interested in the above land, who has any objection to the acquisition thereof may within thirty days after the date on which public notice of the substance of this notification is given in the locality file an objection in writing before the Collector, Birbhum.
