

Birbhum.—No. 21140L.A.(P.W.).—3rd December 1956.—Whereas 14.52 acres, more or less, of land situated in or near the villages of Paikpara and 2 others, described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for irrigation and drainage, namely, for Distributary No. 7 of Ex. Brahmani North Main Canal in connection with Mayurakshi Reservoir Project;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act the Governor acquires such land being required for a public purpose as aforesaid.
