(Roads) dated—13th May 1998—Whereas the Governor is satisfied that land is needed for a public purpose, not being a purpose of the Union, namely for construction of Sainthia to Dwaraka, Bolpur—Rajgram Road in the Mouzas Dumra & Hossainganj, Jurisdiction List No. 11 & 12, P. S. Mayureswar, District Birbhum it is hereby declared that a piece of land comprising Revisional settlement plots as detailed below and measuring, more or less, 4.1743 hectares (10.315 acres) bounded as specified below is needed for the above said public purpose at the public expense within the aforesaid mouza(s).

2. The declaration is made under the provision of section 6 of Act I of 1894 to all whom it may concern.

BIRBHUM No. 1202 LA/LR-9/97, dated 18th February '97—Whereas it appears to the Governor that land is likely to be needed to be taken by Government at the public expense for a public purpose viz. for construction of Sainthia to Dwaraka, Bolpur—Rajgram Road (6 K.M. to 7.760 K.M.) in the Mouza:- Dumra, Hossainganj Jurisdiction List No. 11, 12, P. S. Mayureswar, District Birbhum, it is hereby notified that for the above purpose a piece of land comprising revisional Settlement plots as detailed below and measuring, more or less 4.1743 hectares (10.315 acres) bounded as specified below is likely to be needed within the aforesaid mouza.

This notification is made under the provisions of section 4 of Act 1 of 1894, to all whom it may concern.

A plan of the land may be inspected in the office of the Collector, Birbhum.

In exercise of the powers conferred by the aforesaid section, the Governor is pleased to authorise the officers for the time being engaged in the undertaking, with their servants and workmen, to enter upon and survey the land and do all other acts required or permitted by that section.

Any person interested in the above land, who has any objection to the acquisition thereof, may, within thirty days after the date on which public notice of the substance of the notification is given in the locality, file an objection in writing before the Collector, Birbhum.
