BHUM.—No. 15530-L.A.(P.W.).—11th August 1969.—Whereas 3.826 hectares (9.565 acres), more or less, of land situate in or near the villages of Batikar and others described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section, 3(1A) of the Act for the public purpose of providing facilities for transport and communication, namely, for the construction of Batikar-Kurmitha Village Road (1 m.p. to 2 m.p. 19.50 chainage);

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.
