

**Birbhum.**—No. 20076L.A.(P.W.).—21st November 1956.—Whereas 88.10 acres, more or less, of land situate in or near the village of Swadinpur and 13 others described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for irrigation and drainage, namely, for permanent acquisition of land for distributary No. 3 of Dwarka Brahmani Branch Canal in connection with Mayurakshi Reservoir Project;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act the Governor acquires such land being required for a public purpose as aforesaid.
