#### Land Acquisition

#### NOTICE

BIRBHUM—No. 131 L A (II)/Spl/P. W. (Road) 24th June, 1992— whereas 1.8420 hectares or (4.56) acres, more or less, of land situated in or near the villages of Husaipur and two others described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (1A) for the purpose of providing facilities for transport / communication namely for construction of Kulkuri-Muralpur Road (Section 8th to 10th K. M.).

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948, (West Bengal Act II of 1948), to all whom it may concern.

A plan of the land may be inspected in the office of the Collector, Birbhum ( Special Land Acquisition Department.) Suri.
