

MURSHIDABAD.—No. 16470-L. A. (P. W.).—  
 26th December 1970.—Whereas 2.48 acres (1.0036  
 hectares), more or less, of land situate in or near the  
 villages of Matai and Bhalkundi described below have  
 been requisitioned under sub-section (1) of section 3 of  
 the West Bengal Land (Requisition and Acquisition)
