**Birbhum.**—No. 16266L.A.(P.W.).—19th August 1959.—Whereas 44.87 acres, more or less, of land situate in or near the villages of Amba and eight others, described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for transport and communication, namely, for the construction of Mollarpur-Nalhati Road—portion from 2nd mile post to 7th mile post;
