BIRBHUM.—No. 15785.-L.A.(II)/II-125/68.—23rd November 1968.—Whereas .9340 of a hectare (2.31 acres), more or less, of land situate in or near the village of Gaysabad and others described below has been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3 (1A) of the Act for the public purpose of providing facilities for irrigation, namely, for excavation of new minor No. 2 E of Distributary 15 offtaking Chainage 419.00 of Distributary No. 15 Ex. K.S.M.C.;
