BIRBHUM. No. 6240L.A.(P.W.)/II-80/77.—7th April—1977. Whereas 6·8068 hectares (16·82 acres), more or less of land situated in or near the villages of Gomra and others described below have been requisitioned under sub-section (I) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3 (1A) of the Act for the public purpose of providing facilities for irrigation and drainage, namely, for works repairs and rebuilding ex-zamindary left Ajoy embankment from mauza Jahanabad to Narenga ;
