

Birbhum.—No. 3716L.A.(P.W.).—17th February 1959.—Whereas 35·11 acres, more or less, of land situate in or near the villages of Sadinpur and others described below have been requisitioned under subsection (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for transport and communication, namely, for the construction of Mallarpur-Rampurhat-Nalhati Road (from 12th mile to 16th mile) ;
