

BURDWAN.—No. 10672-L. A. (P. W.)/II-82/77.—1st August 1977.—Whereas 2-4402 hectares (6-03 acres), more or less, of land situated in or near the village of Narenga described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3(1A) of the Act for the public purpose of providing facilities for irrigation and drainage, namely, for repairs and re-buildings of ex-Zamindary left Ajoy Embankment from mauza Jahanabad to Narenga;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948,) to all whom it may concern.
