NOTICES

BURDWAN.—No. 19023-L. A. (P. W.)/II-292/73.—15th October 1973.—Whereas 1.9140 hectares (4.73 acres), more or less, of land situated in or near the villages Panchandi and Nirod described below, have been requisitioned under sub-section (I) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3(1A) of the Act for the purpose of providing facilities for irrigation and drainage, namely, for permanent acquisition of land, in connection with continuous water course from distributory No. 18 of Kopai South Main Canal.
