(P.W.). — 2nd 1954.—Whereas 194.945 acres, more or of land situate in or near the villages of or, Keshradihi and others described below been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for irrigation and drainage, namely, for the construction of Kopai South Main Canal in connection with the Mayurakshi Reservoir Project:

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act the Governor acquires such land being required for a public purpose as aforesaid.
