

BIRBHUM.—No. 16798 L.A.(II)/11-241/68.—4th December 1968.—Whereas 1.7623 hectares (4.355 acres), more or less, of land situate in or near the villages of Mala, Keshabpur, Chaknarayanpur, Digha, described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3(1A) of the Act for the public purpose of providing facilities for irrigation and drainage, namely, for construction of Distributary No. 4A Ex. K.S.M.C. in connection with Mayurakshi Reservoir Project;

Now, therefore, notice is hereby given that in pursuance of section 4(1a) of the said Act the Governor acquires such land being required for the public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.
