DECLARATIONS

BIRBHUM.—No. 7404L.A./1R-17/64.—28th April 1964.—Whereas the functions of the Central Government under the Land Acquisition Act, 1894 (Act I of 1894), in relation to the acquisition of land for the purpose of the Union, have been entrusted to the State Government by notification No. 20|155Judl.(1), dated the 14th May 1955, issued by the Government of India in the Ministry of Home Affairs under clause (1) of Article 258 of the Constitution of India as S.R.O. 1074, and published at page 868, Part II, section 3 of the "Gazette of India", dated the 21st May 1955;

And whereas the Governor is satisfied that land is needed for a public purpose, namely, for the construction of double line on the Sahibganj Loop (Loop Line) between Sainthia and Barharwa (from 132 mile to 135 miles), in the villages of Palsa, jurisdiction list No. 55, Chituri, jurisdiction list No. 24, Harioka, jurisdiction list No. 73, Barsal, jurisdiction list No. 72, Majkhanda, jurisdiction list No. 23, and Sri Krishnapur Pakuria, jurisdiction list No. 75, all under police-station Rampurhat, pargana Koar Pratap, district Birbhum, it is hereby declared that pieces of land comprising cadastral plots as detailed below and measuring, more or less, 8.805 acres, are needed for the aforesaid public purpose at the public expense within the aforesaid villages.
