

Murshidabad. — No. 1656L.A.(P.W.). — 24th January 1956.—Whereas 33.45 acres, more or less, of land situated in or near the village of Eroly, and 4 others described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for irrigation and drainage, namely, for construction of Distributary No. 17 of Mayurakshi Dwarka Branch Canal in connection with Mayurakshi Reservoir Project;
