BIR BHUM No. 58-L.A./8/2001-2002/C. & I./2001 dated 2nd August, 2001—Whereas it appears to the Governor that land is likely to be needed to be taken by Government at the public expense for a public purpose, viz, for Setting up a new growth centre at Bolpur in the mouza Shibpur, Jurisdiction List No. 102, P. S. Bolpur. District Birbhum, it is hereby notified that for the above purpose a piece of land comprising L. R. Plots as detailed below and measuring more or less, 5-5748 hectares (13-775 acres) bounded as specified below is likely to be needed within the aforesaid mouza Shibpur.

This notification is made, under the provisions of section 4 of Act I of 1894, to all whom it may concern.

A plan of the land may be inspected in the office of the Special Land Acquisition Officer, Birbhum at Suri.
