NOTICES

PURULIA.—No. 892-L.A.(P.W.)/11-577/74.—11th January 1975.—Whereas 1.6096 hectares (3.9775 acres), more or less, of land situated in or near the village of Cheliama described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948 by the person authorised under section 3(1A) of the Act for the public purpose of providing facilities for irrigation and drainage, namely, for excavation of canal of Bandhajore M. I. Scheme.

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act the Governor acquires such land being required for a public purpose as aforesaid.
