BIRBHUM—No. 51-L.A. (II /Spl /I & W dt. 23rd, June, 1992—Whereas 0·42 of an acre or 1700 hectare, more or less, of land situated in or near the village of Biralchouki described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (1A) for the purpose of providing facilities for irrigation, namely for a lead channel from tail of Water Course from Ch. 228·00 (Lt) of B.
