

**Notice.** No. 219821-A (P.W.)—13th December 1956.—A heron 112.15 acres, more or less of land situated in or near the villages of Bhurab and some others described below, have been requisitioned under sub-section (1) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section (1) for the purpose of providing facilities for irrigation and drainage, namely, for Distributary No. 15 of the Kaptai South Main Canal in connection with Kaptai Reservoir Project;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act the Government acquires such land being required for a public purpose as aforesaid.
