Burdwan.—No. 434L.A.(P.W.).—8th January 1957.—Whereas 10.555 acres, more or less, of land situated in or near the village of Keuguri, described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for irrigation and drainage, namely, for Distributary No. 26 Ex Kopai South Main Canal from chainage 78 to chainage 152 in connection with Mayurakshi Reservoir Project;
