

Birbhum. — No. 25698L.A.(P.). — 28th December 1955.—Whereas 107.325 a res, more or less, of land situate in or near the villages of Mohammadbazar, Chilla and others, described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for transport and communication, namely, for the construction of Mohammadbazar-Deucha-Mollarpur State Highway;
