LAND AND LAND REFORMS DEPARTMENT Land Acquisition NOTIFICATION

BIRBHUM No. 24-LA/97/96-97/P.H.E./99 dated 15th February, 1999—Whereas it appears to the Governor that land is likely to be needed to be taken by Government at the public expense for a public purpose, viz, for construction of administrative buildings of PHE Dte in the mouza Surul, Jurisdiction List No. 104, P. S. Bolpur, District Birbhum it is hereby notified that for the above purpose a piece of land comprising revisional settlement plots as detailed below and measuring, more or less, *9591 hectare (2.37 acres) bounded as specified below is likely to be needed within the aforesaid mouza Surul.

This notification is made, under the provisions of section 4 of Act I of 1894, to all whom it may concern.

A plan of the land may be inspected in the office of the Special Land Acquisition Officer, Birbhum, Suri.

In exercise of the power conferred by the aforesaid section the Governor is pleased to authorise the Officers for the time being engaged in the undertaking, with their servants and workmen, to enter upon and survey the land and do all other acts required or permitted by that section.

In exercise of the powers conferred by sub-section (4) of section 17 of the Land Acquisition Act, 1894 (Act-I of 1894), the Governor is pleased to direct that the provisions of section 5 A of the Act shall not apply to the lands as described in the schedule below to which in the opinion of the Governor, the provisions of Sub-section (1) of section 17 of the said Act are applicable.

BIRBHUM No. 26-L.A./97/96-97/PHE/99 dated 9th March 1999—Whereas the Governor is satisfied that land is needed for a public purpose, not being a purpose of the Union, namely, for construction of administrative buildings of P.H.E. Dte. in the Mouza Surul, Jurisdiction List No. 104, P. S. Bolpur, District Birbhum, it is hereby declared that a piece of land comprising revisional settlement plots as detailed below and measuring, more or less, 9591 hectare (237 acres) bounded as specified below is needed for the above said public purpose at the public expense within the aforesaid mouza Surul
