## ORDER

WHEREAS in my opinion it is necessary for the purpose of providing proper ~~transport~~ <sup>communication</sup> viz. for the construction of the permanent acquisition of land for Malhati-Murarai Rajgaon with a link road connecting Nitrapur-Murarai Road in connection with the..... to requisition the lands described in the schedule below.

And whereas the Provincial Government has, by notification No. 3775-L. A. ( P. W. ) dated 11. 5. 48.
