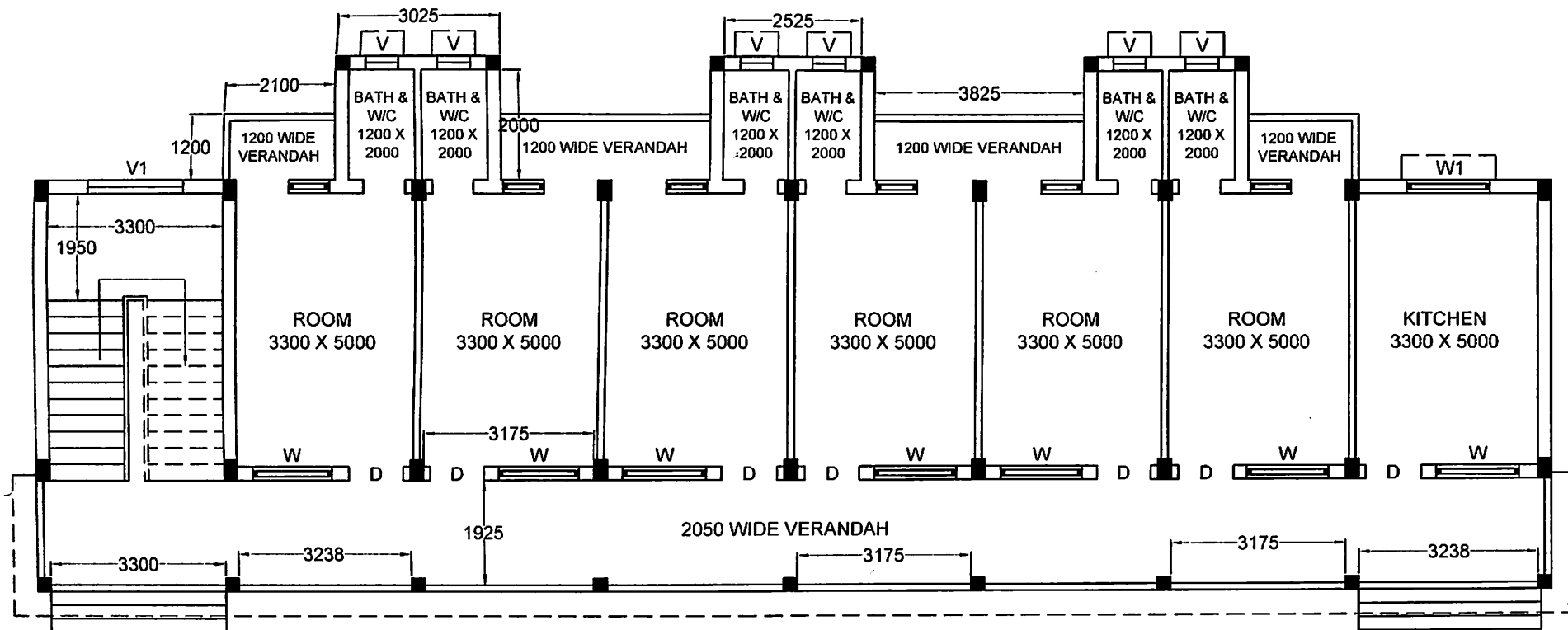


Ground Floor Plinth Area = 245.21 SqM
