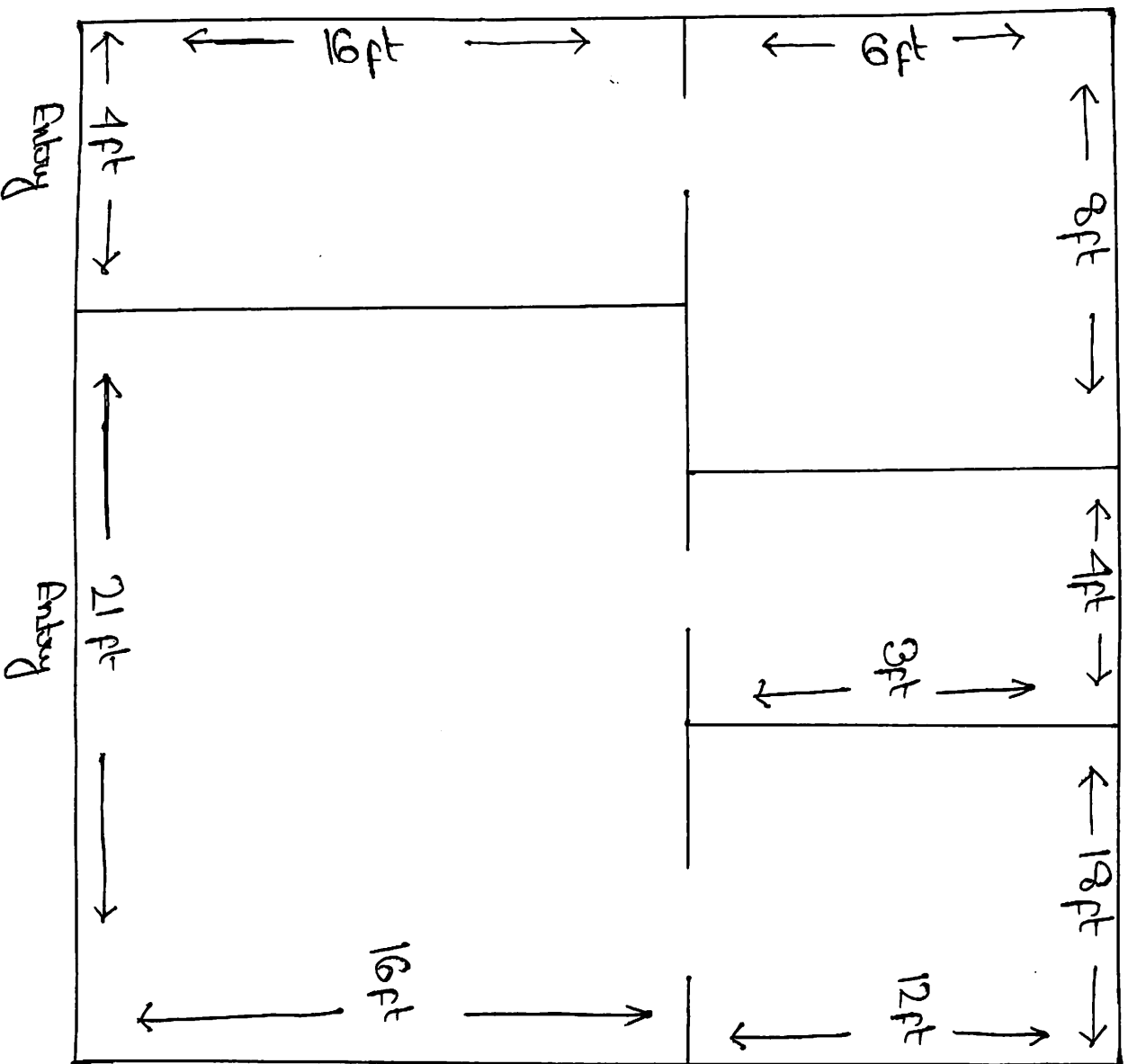


Sub: Proposal for post-facto administrative approval towards rent of privately owned premises for usage of Excise Office/Barrack
