In view of above, enhancement of rent will be

- 1) **20%** of ₹ 6,746/- and come to ₹ $\{6,746/- +(20\% \text{ of } ₹ 6,746/-)\} = ₹ 6,746/- + ₹ 1,349.20/- i.e. ₹ 8,095.20 i.e. ₹ 8,095.00 per month w.e.f. 01.03.2012 (upto Five years).$


